Further to our previous correspondence regarding your request for the following information:

A consultee response, being ONR Land Use Planning, to correspondence issued by West Berkshire District Council associated with Planning application no: 20/02029/COMIND, Site: Reading Quarry, Berrys Lane, Burghfield Proposal: Development of an Energy Recovery Centre and adjacent Data Centre and associated infrastructure Date Validated: 16 September 2020, recommends ""... the applicant liaise with AWE Burghfield in relation to the potential external hazards the proposed development poses to AWE Burghfield and vice versa, if they have not already."" (for ease of reference, a copy of the correspondence is attached). In respect of the question posed I would be most grateful if AWE can provide the following:

- 1. Details of correspondence sent to AWE in relation 20/02029/COMIND.
- 2. Details of AWE's subsequent response to correspondence received as referenced in point 1 above.
- 3. Details of notes made following verbal discussions relating to 20/02029/COMIND.
- 4. Details of correspondence received from West Berkshire District Council inviting AWE to respond to Planning application no: 20/02029/COMIND.
- 5. Details of AWE's response(s) to West Berkshire District Council following receipt of correspondence received from West Berkshire District Council as referenced in point 4 above.

Your request has been handled as a request for information under the Environmental Information Regulations 2004 (EIR).

Thorough searches have been carried out to locate the information you requested and we can confirm that the Atomic Weapons Establishment (AWE) has not been able to locate any relevant information. The exception at regulation 12(4)(a) of the EIRs, which relates to information deemed not to be held at the time when an applicant's request is received applies to the information you have requested. Regulation 12(4)(a) is a qualified exception, which usually means that a public authority is required to conduct a public interest test to determine whether or not information should be disclosed or withheld. However, the Information Commissioner's Office (ICO), who is the independent regulator for requests made under the EIR, takes the view that a public interest test in cases where the information is not held would serve no useful purpose. Therefore, in line with the ICO's view, AWE has not conducted a public interest test in this case.

Please note the Commissioner will generally not consider a complaint until you have exhausted AWE's internal complaints process.
